# SAP Proces : B.Tech. / MBA Tech.

#### Before counseling

- NMIMS-CET Scores will be uploaded in SAP along with candidate's data through API.
- Phase-wise offered seats / buffer will be maintained in the SAP and seat allotment will be done accordingly.
- Phase-1 candidates will be considered in Phase-2. New merit will be executed with their best score in Phase-2.
- A general Merit list will be prepared based on NMIMS-CET Scores & Tie breaker.
- Candidates will be called for admission counselling as per merit number for each phase.

#### **During Counseling**

- Candidates will be admitted in program depending on availability of the seat in each program irrespective of the preference given during registration and subject to eligibility criteria.
- Candidate may take admission in higher preference in Phase-2. In this case, his first admission will get cancelled immediately in SAP.
- Online preference minimum 1 & maximum 2 will be taken from candidate along with PCM Percentage.

## After Counseling

• Once the cancellation is received from candidate during / after admission counseling, Upgradation process will be activated to fill the vacant seat on the basis of merit, preference & vacant seat after completion of admission counseling round.

#### Upgradation process

- On cancellation, the vacant seat is offered to next eligible candidate as per merit and preference.
- Candidate has to confirm the offer in writing within time limit allotted for acceptance.
- If accepted, candidate gets transferred to that specialization. If rejected or not accepted within given time limit candidates are **not eligible** for further up-gradation and remains in the same admitted specialization.
- Upgradation is applicable to candidate based on merit & highest preference given by candidate & vacancy.
- If a candidate has given two preferences during counseling & he has been allotted upgradation in first preference then his second preference will be null and void & if he has been allotted in second Preference then his first preference will be active for further upgradation provided vacancy arise.

#### Non NMIMS-CET / Admission against vacant seats

- After completion of ugradation process for NMIMS CET candidate & if seats remain vacant, seats will be filled up by the Non NMIMS-CET candidates on the basis of marks obtained in 10+2 examination.
- Data of Non NMIMS-CET candidate will be uploaded in SAP & merit list will be prepared separately based on 10+2 & diploma score. 10+2 candidate merit list will be generated in SAP prior to Diploma candidate.
- Non NMIMS-CET merit number will be in continuation of NMIMS-CET candidate list
- Upgradation rule / process will not be followed for NMIMS-CET and Non NMIMS-CET.
